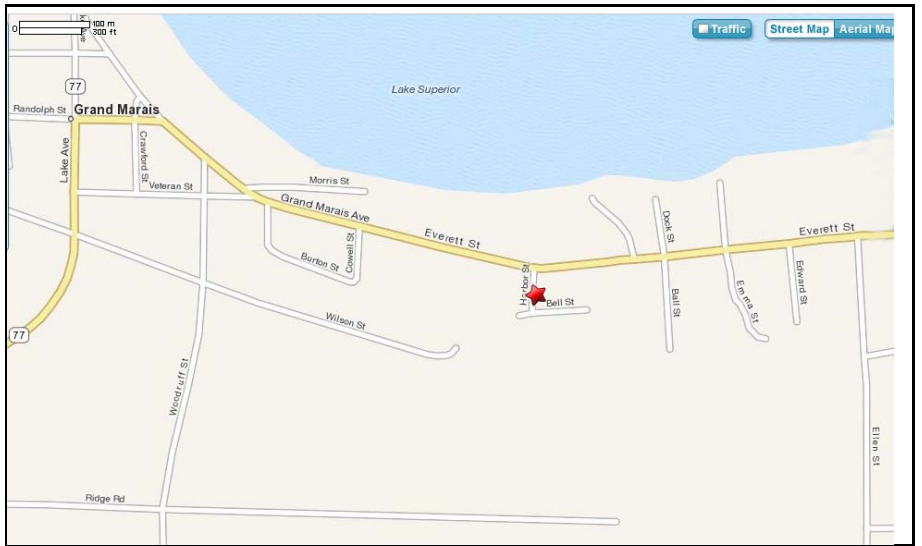

## NON-DISCRIMINATION STATEMENT
