### Services

#### *In Home Hospice Care*

**SERVICE DESCRIPTION:** Provides a full range of palliative and supportive services for terminally ill people who are in the final stages of their illness and their families in their place of residence. Bereavement counseling and respite care will be provided as part of the hospice services.

**ELIGIBILITY:** - Terminally ill individual with 6 months or less to live  
- Referral from a physician

**DOCUMENTS REQUIRED:** Identifying information and medical insurance information

**FEES:** - Reimbursement for services may come from Medicare/Medicaid or private insurance carriers - Assistance is available in determining coverage and if no insurance coverage is available an acceptable payment plan can be developed
